

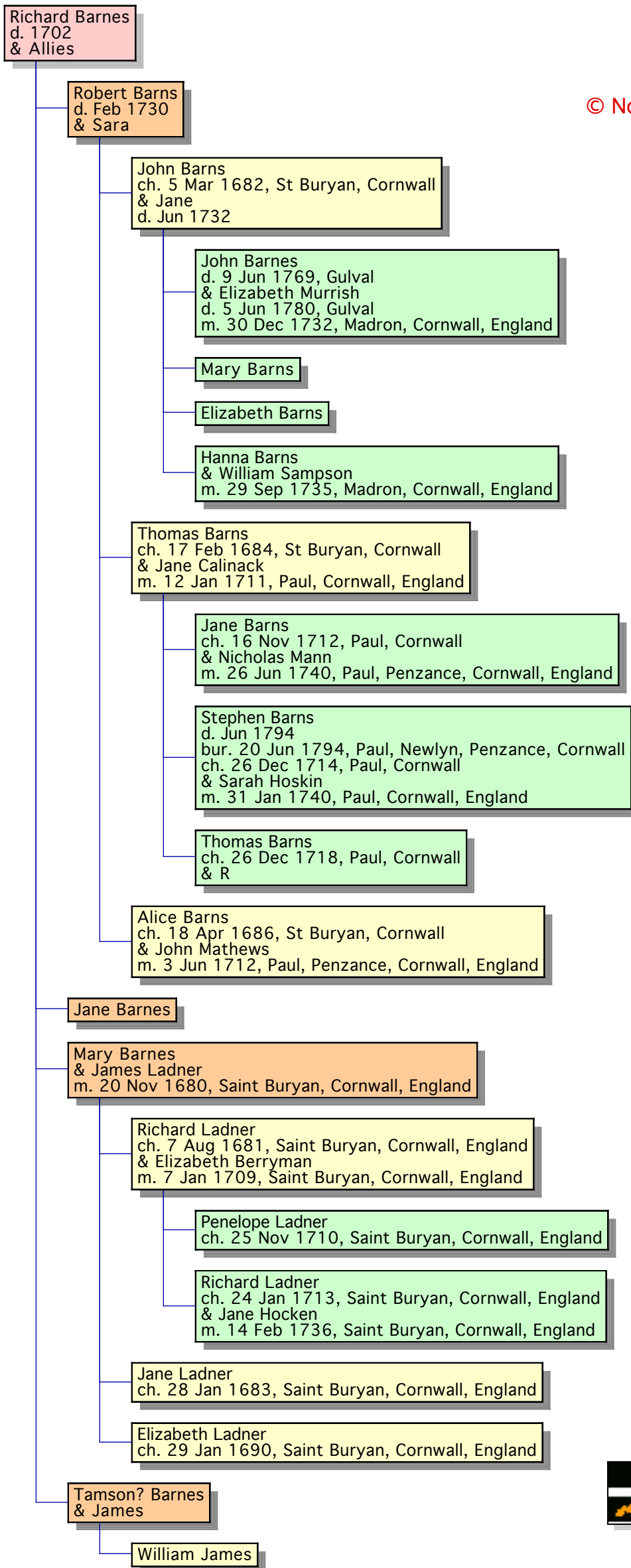

I BEQUEATH & COMEND MY BODY TO ITTS FIRST ORIGINALL YE EARTH TO HAVE A DECENT & COMELY BURIALL

I GIVE & BEQUEATH UNTO MY DAUGHTER JANE NINE POUNDES & TEN SHILLINGS Y^T IS OUTT UPON BAND & ONE COW & ONE BED FURNISHED AFTER YE DECEASE OF HER MOTHER

I GIVE & BEQUEATH UNTO MY SON IN LAW RICHARD NICHOLL THIRTY SHILLINGS

I GIVE & BEQUEATH UNTO MY SON ROBERT BARNES THE GROAT CROCK

I GIVE & BEQUEATH UNTO MY GRAND DAUGHTER MARY BOSEFRON TEN SHILLINGS & A HEIFER CALFE & ONE PAN

I GIVE & BEQUEATH UNTO MY SON IN LAW THO. NICHOLL TWELVE POUNDS REMAINING IN HIS HAND ALREADY

I GIVE & BEQUEATH UNTO ALLIES MY WIFE YE TENEMENT IN LUDGVEN & ALL YE REST OF MY GOODS MOOVEABLE & UNMOVEABLE & DOO HEREBY MAKE HER MY SOLE EXECUTOR OF CORNE IN YE GROUND HORSES BULLOCKES HOUSEHOLD GOODS & ALL OTHER THINGES UNMENTIONED WITH PAYING TWELVE PENCE A PEICE TO ALL YE REST OF MY GRAND CHILDREN TO BE PAYD ONE YEARE AFTER MY DECEASE & IN TESTYMONEY HEREOF I RICHARD BARNES HAVE HEREUNTO SETT MY HAND & SEALL YE DAY & YEAR ABOVE SAYD 11TH APRILL 1698
